# Lane County's Local Workforce Board Reappointment Recommendation

## BACKGROUND

On July 22, 2014, President Obama signed the Workforce Innovation and Opportunity Act (WIOA). Under WIOA, the Chief Elected Official in a local area is authorized to appoint the members of the local workforce board. In Lane County, the Chief Elected Official is made up of multiple units of local government, which include Lane County and the cities of Eugene, Springfield, Cottage Grove, and Florence.

# Lane County's Local Workforce Board Membership Recommendation
